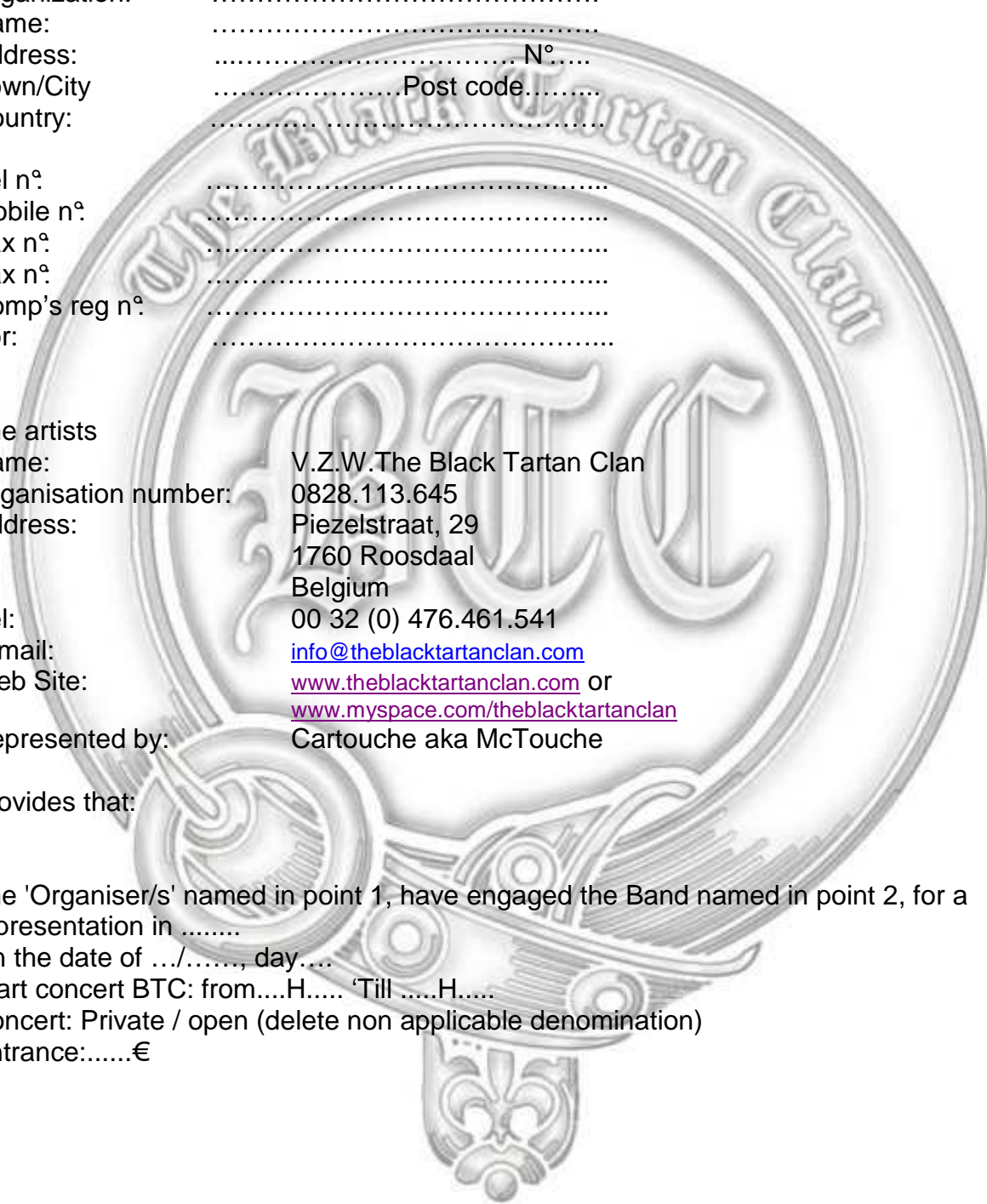

5. The 'Organiser/s' is obliged to fill in the contracts, and send two signed copies to 'The Black Tartan Clan' at the latest date .....

The contract will become valid when the artist (or a recognised representative) has signed and returned the second contract to the 'Organiser/s'

6. The non-application of points 4 and 5, even partial non-application, by the 'Organiser/s' allows the 'Band' mentioned in point 2, to annul the contract.

7. In case of non-payment of the commission or sum agreed by the 'Organiser/s', or non application of the contract, the 'Organiser/s' accepts to pay an indemnity of 20% of the sum agreed at the signature of the present contract. Also an addition of 12% for dedomagement.

8. The 'Organiser/s' declares that they have knowledge of the artists repertoire and will not discuss the content.

9. Verbal agreements are only valid when they are confirmed by a written agreement by the interested party, point 5.  
Eventual corrections or modifications are only valid if the interested party paragraphs them.

10. Any eventual contestation of contract validity or execution of said contract, only the Tribunal Court of Alost ,Belgium, will be competent to decide.

11. The 'Organiser/s' provides, at 'Organiser/s' costs, accommodation for the aforementioned artists and eventual entourage as described above.

12. The Artists/Band can give the 'Organiser/s' a **Backstagelist of 16 people** and a **guestlist with MAX 5 names**

13. The concert cannot be interrupted by a third party to make announcements, except of course in the situations of fire and other emergencies. Any announcements can be made after the concert.

14. The 'Organiser/s' provides, at their costs, the following articles for the band and entourage on the stage or in the band room.

4 crates of beer (Jupiler)  
3 bottles of flat water  
3 bottles of Coca Cola

15. The 'Organiser/s' provides sandwiches for 16 people, before or after the representation (to be decided on the day).

16. if possible, preserve a parkingspace for the vehicles 042BTC & .....  
This for loading & unloading the gear. If possible during the whole gig from start 'till end.

17. if possible a table of 2M (with eventually sober light) and 2 chairs for the merchandise. Selling start at the beginning of the concert until 1h30min after the gig.

18. The Band, 'The Black Tartan Clan' will be aided/mixed by their own P.A. Technician (if there is not a resident technician) or by the resident technician.

19. The lighting system will be mixed/aided by 'The Black Tartan Clan's' own technician (if there is no in house technician) or by the in house P.A./Lighting technician.

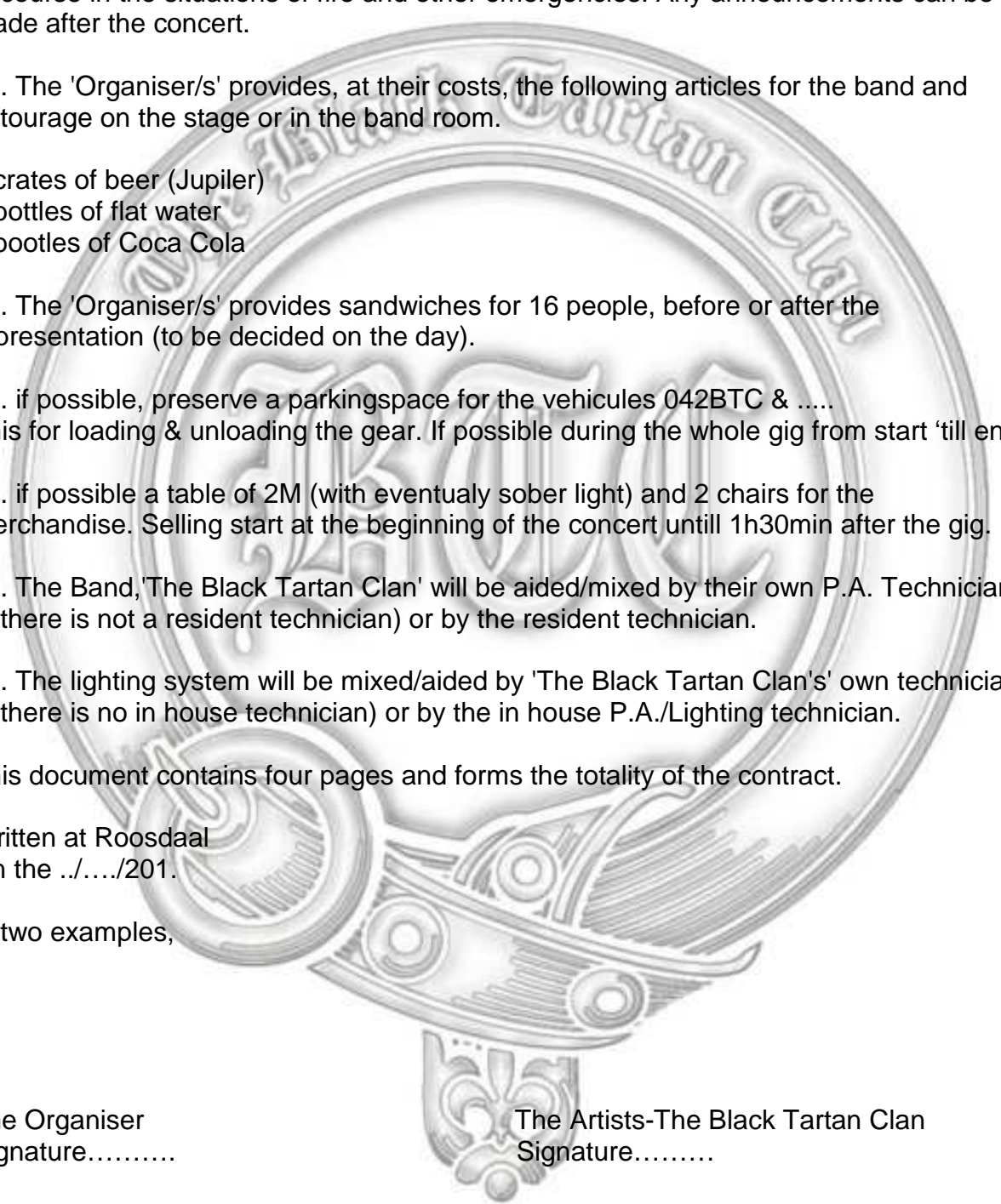
